Section 3 Care homes. 33. Section 3 defines a care home as any home which provides accommodation together with nursing or personal care for any person who is or has been ill (including mental disorder), is disabled or infirm, or who has a past or present dependence on drugs or alcohol. The definition is intended to include residential care homes and nursing homes, as defined in the 1984 Act.

Part IV concerns the functions and procedures of the General Social Care Council (GSCC) and Care Council for Wales (CCW) (Cyngor Gofal Cymru), referred to collectively as "the Councils". The Act established a general social care council for England and a Care Council for Wales. The regulations introduced a qualification framework, with N.V.Q targets set for managers and care staff. The councils will register social care workers, regulate the training of social workers and raise standards in social care through codes of conduct and practice.
