The PPO's investigation found that nearly one in five of those diagnosed with a mental health problem received no care from a mental health professional in prison. The PPO also found that no mental health referral was made when it should have been in 29% of self-inflicted deaths where mental health needs had already been identified. 40% of prisons inspected in 2016–17 had inadequate or no training for prison officers to know when to refer a person for mental health support.

Since November 2015, there have been five deaths in custody in Northern Ireland, four relating to mental health issues. On 17 November 2016, the prison population totalled 1,533. Of these, 417 were recorded as having a mental illness, and a further 740 prisoners were recorded as having an addiction.

Mental health problems are the most significant cause of morbidity in prisons. Over 90% of prisoners have a mental disorder. The prison environment and the rules and regimes governing daily life inside prison can be seriously detrimental to mental health.

With around 1500 prisoners and an estate of three prisons, the Northern Ireland Prison Service is a very small prison service. This inquiry was undertaken to examine whether the estate was adequate and appropriate for the secure accommodation of Northern Ireland's prisoners and whether the Prison Service meets the health, education and training needs of prisoners. One of the main conclusions is that the Current Comprehensive Spending Review does not provide sufficient capital for the substantial redesign of the prison estate. If criminal justice is to be devolved the Committee hope that capital investment in the prison estate will be a priority of the Northern Ireland Executive. If not the Secretary of State will have to argue for an increase in funding.

This book is about the need for social reform programs along with the Department of Corrections to gain more appropriate and more satisfying treatments for affected individuals. Studies have shown that more inmates, upon release from incarceration, have little to no resources that help with assistance of mental health treatment, employment, housing, and education. Redirecting and modifying upon release would help the inmate not only with what's out in the community to face but also in helping to ease the tension of it. Programs and access to mental health resources—medication, continuous counsel, skill-building, and everyday living skills—prove to make a major positive impact on one's transition. Active mental health treatment deemed by the inmate's release team should proactively be a team consensus for the inmate on a long-term basis to redirect the thoughts of recidivism. With all involved, a power of guidance would leave one feeling as though they have a strong sense of support. I believe that by implementing these measures at the beginning of juvenile delinquency, the problems we face in America would result to a lesser number of incarcerations. It is a problem that starts in the adolescent years, not in adulthood. Proper and early treatment of mental illness, diagnosis, and treatments would make a world of difference in the lives of such population. Proper and more guided involvement would lessen thoughts of crime.
