A school district must conduct an initial evaluation to determine if the student qualifies for special education within 60 days of receiving consent.

The federal Individuals with Disabilities Education Act or IDEA as well as New Hampshire state law require school districts to provide special education and related services for children with certain types of disabilities who, due to their disability, need specialized instruction and related services to receive an appropriate education.

It is legally binding which means that the LA and schools must comply with it or else they are acting unlawfully. The Individuals with Disabilities Education Act, or IDEA, was created in 1990 and is a modification of the Education for All Handicapped Children Act. This law ensures that special needs students receive appropriate free public education in the least restrictive environment necessary to meet those students' needs.

An Overview of Special Ed Law. The federal government, under U.S. Code Title 20, Chapter 33, ensures rights to disabled students and their families through a law called the Individuals with Disabilities Education Act (IDEA). This act is the crux of special ed law, because it governs how states and public agencies provide early intervention, special education, and related services to children with disabilities.

An Overview of Special Ed Law - FindLaw

The outcome of PL 94-142, now referred to as the Individuals with Disabilities Education Act, or IDEA (PL 108-446), is special education as we know it. Most recently reauthorized in 2004, it is the main law regarding educational services for students with disabilities, and its specific components are important to their education.

Special Education and the Laws That Affect It

Section 20 Children and Families Act 2014 defines a child as having Special Educational Needs (SEN) if he or she has a learning difficulty or disability which calls for special education provision to be made for him or her. A child is considered to have a learning difficulty if she or he:

You do not need the agreement of the school or Local Authority to home educate your child, unless the child is attending a special school under a Statement of Special Educational Needs or Education Health and Care Plan (EHCP).
